

TERMS AND CONDITIONS

- Roofco shall not assume any legal liability in relation to the assembly and installation this product. Roofco shall furthermore not assume legal liability for damages caused to this product or other accidents caused or damages incurred while the purchaser and/or end-user is assembling or installing this product.
- The purchaser and/or end-user is required to maintain the product by cleaning with only water and a suitable gentle soap product at regular intervals not being more than 6 months apart.
- This product shall not be installed within 5 kilometres of the sea-side
- The purchaser and/or end-user is required to follow the instruction manual provided for the purposes of assembly and installation of this product.
- The purchaser and/or end-user is furthermore required to ensure that the land and/or property and/or area in/on which this product is to be installed is suitable for such installation and stable enough to carry the weight and size of the structure. If necessary, the purchaser and/or end-user is to engage the services of a structural engineer or other suitable professional to inspect the property and/or area to confirm that the product may be installed thereon.
- The assembly and installation of this product shall be performed by the purchaser and/or end-user at his/her/its own responsibility.
- In the event that the purchaser and/or end-user engages the services of an assembler for the assembly and installation of this product, the assembler will also be deemed to be included under the provisions of these terms and conditions. In any event, any and all responsibility arising from such assembly services shall be assumed by such assembler. Roofco shall not assume such responsibility.
- No warranty claim will be entertained due to structural failure, wholly or partly due to an event or cause beyond the reasonable control of Roofco including without limitation each of the following:
1. degradation of the frame as a result of prolonged exposure to the external environment during storage or erection; 2. aesthetic surface corrosion including white corrosion or red rust; 3. failure of framing due to the retention of moisture by any adjoining building materials; 4. corrosion of the framing resulting from the degradation of other materials, components or corroded fasteners; 5. defects attributed to faulty installation or assembly; 6. mechanical, chemical or other damage sustained during transport, handling, storage, erection or subsequent to erection; 7. contact with soil, ash, fertilizer, moisture retaining substances, lead or copper and other dissimilar metals, liquid from copper flashings or copper pipes, chemical or other agents, fumes, liquids or solids, green or wet timber or treated timber; 8. failure to remove debris and/or allow free drainage of water (including condensation) from all surfaces of the end product; 8. failure to install, use and maintain the frame in accordance with guidelines and applicable industry standards; 9. installations subject to severe industrial or unusually corrosive environments at any time in the future; 10. accidental or intentional damage by a person or animal; earthquakes, hurricanes, tornadoes, cyclones, typhoons, gales, lightning, hail, fires, flood and other similarly extreme "acts of God"
- The risk in and to the goods shall pass to the purchaser / end-user from the date of purchase.
